## MEETING NOTICE

## JUNE MEETING MINUTES

*The minutes were approved as printed in the newsletter.*

**President's Report** – Nothing to report.

**Treasurer's Report** – We have \$4419 in checking and \$2897 in savings. For the June Hunt Test, we took in \$7613.44 for entries, less scratches and the fees for Entry Express for catalogs and mailing postcards. The ducks were \$2950, and we sold 20 ducks so this expense is really \$2790. So far our profit is \$2206, there are still some bills to come in. The DFI report has been filed, we were past due for 7 years.

**Secretary's Report** – Judges seminar June 23 and August 11-12. I received a letter from AKC indicating that the results from the June Hunt Test had been processed. We really need to finalize the August judges soon.

**June Hunt Test** – Went well, but we really could have used more help. Does anyone have ideas for an organization that we could hire to help, like ROTC or something? We need to make sure MCKC cuts the grass before the August Hunt Test. The running order and precedence of the Master stake over the other stakes was discussed.

**By-Laws** – The bylaws are now posted on the IVRC website. Any changes we make will need to be approved by AKC. We should look into making changes before the end of the year.

**Club Training Group** – Monday and Wednesday evenings at Dave Juedes' house. Grass has been cut and bailed.

**August Hunt Test** – The grounds should be in good shape, and we have been promised that the ducks will be better this time. It was decided that no food would be made available for purchase on the grounds, as no one has attended the required food

safety course. Karen will investigate buying sandwiches, water and soda and report back at the next meeting.

**New Business** – Sue Dorscheid asked for the club to approve a policy on mailing ribbons for those who do not pick them up at the Hunt Test. It was decided that ribbons would not be mailed unless the Secretary was contacted ahead of time, and that the fee to mail ribbons would be \$2. This will be posted in the premium and also will be written on the marker board where we map the stakes.

We also decided to change the scratch fee for those who do not have a vet's letter to \$20, from \$15. This is for people who scratch before the start of the test.

It was decided not to have a picnic in July this year, we will instead have a dog training day with a picnic on September 9 at Dave Juedes' house. We will train in the afternoon and then have an early dinner. Everyone should bring a dish to pass.

We need to start negotiating with MCKC for the next contract. It was agreed to continue with a 5-year contract if possible, and to try to keep the cost the same at \$5000 for five years plus \$300 for an extra event each year.

We discussed having a double Junior in June next year, some members are concerned about the amount of workers that would be required as we are such a small club.
