We still need 2 junior judges for the August test; we will have to apply for this shortly it would help to have the judges at the same time. I have ordered judges sheets and they have arrived. I sent the bill to Judy to pay. I also bought stamps and sent that bill to Judy as well. Also the bill to send the trophy from the sanctioned trial to Steve Reynolds, and I have not received a check for this yet. I received a letter from the Master National asking us to make a selection for a Master National judge from region 3 for 2008. We need to return the form by May 21, Anyone wanting input should contact Keith Kiesow, since we couldn't make a decision at the meeting.

Sanction Trial – Suggestions for next year's event for eliminating cost. 1) Use frozen mallards from the August test instead of pigeons. 2) Use .22 blanks when feasible versus poppers. 3) Ribbons instead of trophies. *WisAm is already considering for next year.*

June Hunt Test – We misplaced the Sr. & Jr. ribbons and new ones were ordered and should be here on time. The duck count will be finalized with Tom H after EE closing. Club members that ordered birds need to be paid with a separate check

right away. Sue had sent letters to all the judges asking for their room reservations preferences, etc. Also requesting them to on the grounds @ 3:00pm on Fri. Keith Kiesow & Keith Fiebig will meet the judges. Dave Juedes will get new bird bags. Karen will taking care of the food.

Keith Kiesow will make sure that he has checks available by 6/1 to pay expenses, judges meal and the ducks, etc.
