FEBRUARY MEETING MINUTES

The minutes were approved as printed in the newsletter.

Our new members Chris Goyke, Tanna Robinson and Melissa Dreier were present at the meeting. Welcome!

President's Report – The sanctioned trial is coming up. We will need help. Keith reported that the George Hickox school of dog training would be in Green Bay June 27 – July 1 – the cost is \$1295 with a dog or \$595 without a dog. A couple members said they thought this was more for pointing dogs.

Treasurer's Report – We have \$2897.40 in savings and \$2157 in checking. We paid for the awards banquet, Master National dues, trophies from Hoppers, and Equisure for our club insurance. The insurance company will send a notice to MCKC indicating we are paid. Still have not received dues from a couple people – the Secretary will send another notice.

Secretary's Report – I applied to AKC for the June Hunt test. The committee was listed as Dave Juedes and Keith Fiebig as Co-Chair, Secretary Sue Dorscheid, with committee members Keith Fiebig, Tom Zoellner, Kieth Kiesow, Brian Hartfield and Vince Portelli. Fees were \$55 for Junior, \$60 for Senior and \$65 for Master. The event was approved by AKC – we still need judges and for them to be approved before we can put the event on Entry Express.

Elections – The same Officers and Board of Directors were elected to office this year as last year.

Sanction Trial – Our date is Sunday, April 1. Keith Kiesow has four judges so far, need to have the rest by March 1 to get the premium out on time. We are doing a joint mailing with WAFTC this year, their event is April 15. Keith Fiebig has found a source for pigeons, we will have to pre-pay for them and pick them up. Entry fees have been raised to \$18 and \$12 for puppy to agree with WAFTC entries. Keith Kiesow will check with the tavern, which has changed ownership, to make sure they are still willing to host us. He has purchased shells. Tom Heidl will purchase trophies again this year. We will need helpers.

Hunt Test – The dates for our tests this year are June 2-3 and August 25. Tom Heidl is getting judges, he already has a couple for August. Tom Zoellner is arranging for ducks. Karen agreed to do the food if she can keep the profits and the club pays for worker lunches – this was voted and approved. We talked about applying for the raffle license, Sue will look for the paperwork that Keith found last year. We could do a 50/50 raffle, or buy a zinger winger to raffle. We also have two leftover decoys that were supposed to be judges gifts last year. Mowry is arranging for his friend to make the duck calls for judges gifts again this year – we will have IVRC printed on them, but not the year so they can be re-used if necessary.

Pheasant Hunt – Will be Saturday, February 24 at Rush Lake Hunt Club. Those participating please bring a dish to pass, the club will provide brats, burgers and buns.

Bumpers – Tom Heidl is going to order bumpers, if anyone is interested in ordering some to get the bulk discount let him know.

Shirts – Keith Kiesow brought up the subject of possibly ordering more embroidered shirts to sell. Keith Fiebig agreed to contact Carol Heule to get quotes, Keith Kiesow agreed to contact the person

who did them previously to get quotes and we will compare quotes at the next meeting.

By-Laws – Dave Juedes thought we should have copies of the bylaws on the website, and available for all members. Everyone agreed, but no one has an electronic copy of them. Keith Fiebig agreed to scan his printed copy of the bylaws and make them available.
