JULY MEETING MINUTES

The minutes were approved as printed in the newsletter.

President's Report – Keith mentioned the sporting clays shoot that appeared with the last newsletter, as something fun for club members to do. He thought, and everyone agreed, that the e-mail newsletter worked well.

Treasurer's Report – Our income from the Hunt Test is estimated to be \$1146.74. This month we purchased the 7 wingers for \$1540, and we had two people pay dues for \$40. We have \$2018.48 in checking and \$2895.55 in savings for a total of \$4914.03. We received a thank you note from Donna Brill for the flowers. Tonight we received a bill for six duck calls for judge's gifts for \$300 and bills for \$223.12 and \$49.57 for waste services at the June Hunt Test. We will have to pay Manitowoc next year – if the amount remains the same it will be \$5,000. We need to save some money for a while to be able to pay this. The Treasurer's report was accepted as submitted.

Secretary's Report – The post cards for the August Hunt Test have been sent out by Entry Express. Everyone should have received one. We will have an apprentice judge, it was agreed that we should pay for the apprentice's judge's meal on Friday evening but not his hotel. I received a thank you card from the family of Marv Lind. The Secretary's Report was approved.

Hunt Test – Tom Heidl and Keith Fiebig will meet with the judges on Friday. Sue will make the dinner reservation for the number of judges plus four people. Ducks have been reserved at \$6.50 apiece. We have steel shot and poppers already. The grounds are in good shape and should be mowed as

the field trial is two weeks before us. We decided not to do a raffle because we do not have a license. It takes 2-3 months to apply and costs \$25. We will have brats and burgers again for lunch. We decided to give a meal ticket to volunteers that work at the event that are not club members.

New Business – The duck calls were received from Mowry's friend and passed around for everyone to see.

Someone at Tom Heidl's church is trying to raise money by doing a Walk-a-Thon for dogs – Tom wanted to know if the club would donate – he will bring the information to the next meeting.

Reminder to all – we need helpers for the August Hunt Test – please respond to Tom Heidl if you can help.
